



NCLEX Training and Employment Agreement

1. This agreement is between Nurses4America (Worldwide Emigration Ltd.) of Suite D2, Basepoint Business and Innovation Centre, 110 Butterfield, Great Marlings, Luton, Bedfordshire LU2 8DL, United Kingdom henceforth known as the "Training Provider" and you henceforth known as "the student".
 - a. This is an exclusive agreement between the Training Provider and the student and the student is prohibited to sign with any other NCLEX or CGFNS training provider, US healthcare or US nursing recruitment agency or a direct US healthcare employer for 24 months from the date of signing this agreement.
 - b. After this 24 month period the Training Provider will release the Student from this agreement.

4. The training program comprises of:
 - a. NCLEX® Review 3500 Study Software for NCLEX-RN
 - b. Supplementary NCLEX® Review Book
 - c. IELTS Review if the student's:
 - i. Entry-level NURSING professional education DID NOT occur in the United States, Canada (except Quebec), the United Kingdom, Ireland, Australia or New Zealand.
 - ii. Language of instruction WAS NOT English.
 - iii. Language of textbooks WAS NOT English.

5. The Student's obligations:
 - a. To participate in the Training program.
 - b. To study very vigilantly and dedicate all your free time to the study of the Training program in order to pass AT THE FIRST ATTEMPT the NCLEX-RN® exam and obtain the IELTS Academic band score of at least 6.5 and Spoken band of at least 7.0
 - c. Once the student has passed the NCLEX-RN® exam and obtained the above required IELTS band scores then the student's obligations are as follows:
 - i. To inform the Training Provider that you have passed the NCLEX-RN® exam.
 - ii. To inform the Training Provider that you have obtained the above required IELTS band scores.
 - iii. To be available on the phone at all times so that the Training Provider can schedule telephone interviews
 - iv. To study the telephone interview preparation guidelines thoroughly.
 - v. To study the job and employer descriptions and details thoroughly.
 - vi. To inform the Training Provider of any possible cancellations or re-scheduling of telephone interviews 24 hours in advance of the scheduled telephone interview.
 - vii. To be flexible about the final destination within the United States.
 - viii. Once the job offer has been made to accept the job offer by signing the employment contract and returning it to the Training Provider within 48 hours of receiving the contract.
If the student does not accept the job then the student will be liable to pay a penalty of £1500.00 (one thousand and five hundred British Pounds).

- ix. To take and pass an employer competency evaluation exam with a score of 80% or more.
- x. Responsible to pay for all retakes and reviews of the NCLEX-RN® and IELTS exam and other related costs if not passed at the first attempt.

6. The Training Provider's obligations:

- a. To send all the relevant study materials or online logins and passwords to the Student within 14 days of the fee having cleared in the Training Provider's bank account.
- b. To designate one of its staff to deliver an Orientation to the Program to the Student.
- c. To help the student with all NCLEX-RN® exam registration processing.
- d. To help the student with all IELTS exam registration processing.
- e. Once the student has passed the NCLEX-RN® exam, obtained at least the above required IELTS band scores and obtained 80% or more in the employer competency evaluation exam:
 - i. To provide the Student with telephone interviews with the Training Provider's contracted American nursing employers (henceforth known as "Employers"):
 - 1. The employment vacancies with the Employers are in existence as of the date of this agreement.
 - 2. These vacancies are in existence in 44 States of America as of the date of this agreement. This may change once the student has passed NCLEX-RN® and is ready to be interviewed.
 - 3. The vacancies may vary after the student has passed NCLEX-RN® and is ready to be interviewed.
 - ii. To provide the student with the date and time of the telephone interview.
 - iii. To provide the student with preparation documents before the interview, which may include:
 - 1. Job descriptions
 - 2. Employer details
 - 3. Telephone interview techniques
 - iv. Once the Student has signed the job offer:
 - 1. To provide assistance for nurse and dependents for all immigration, legal and credentialing processes for the purpose of obtaining a legal work status as a Registered Nurse in the United States and becoming a U.S. Resident under the I-140 Immigrant Visa Program.
 - 2. 90 days after the Student has commenced employment at the Employer's place of work, the following will be reimbursed to the Student:
 - a. NCLEX examination fees
 - b. all of the Training Program fees
 - c. all immigration application fees
 - d. transportation costs to testing site for the NCLEX examination.
 - e. airfare to the US when commencing employment

7. Penalty

- a. If the student signs with any other NCLEX or CGFNS training provider, US healthcare or US nursing recruitment agency or a direct US healthcare employer within the aforementioned 24 month period (as mentioned in clause 1.a and 1.b) then the student will be liable to pay a penalty of £1500.00 (one thousand and five hundred British Pounds).
